Must an offshore company register for GST? An offshore company is automatically registered for corporate income tax with the Inland Revenue Authority of Singapore (IRAS) upon incorporation. However, the company may need to separately register for Goods and Services Tax (GST) with IRAS if its expected annual turnover exceeds S\$1 million.
